Applications are invited for filling up the vacancy for the post of Director in National Institute of Food Technology, Entrepreneurship and Management, Thanjavur (NIFTEM-T). The Director of NIFTEM-Thanjavur is the academic and administrative head of the Institute and shall be responsible for the proper administration of the Institute and for imparting of instruction and maintenance of discipline. The powers and functions of the Director are as conferred to him by the NIFTEM Act 2021 and Statutes of NIFTEM. The applicant shall be a distinguished academician with Ph.D or equivalent having at least fifteen years teaching or research experience in the field of Food Science, Technology & Management, and shall have worked as a full Professor at a reputed institution for at least seven years; or shall have food industry experience at a higher level for at least fifteen years. The Director shall hold office for a term of five years from the date on which he/she enters upon his/her office. The age of applicant for the post of Director shall not be more than 65 years as on the date of advertisement for the post. No person shall be appointed as Director for more than two terms. The applicant should be an Indian Citizen. The post carries a fixed pay ₹ 2,10,000 as per Ministry of human Resources and Development order no 1-7/2015-U.II(1) dated 02.11.2017 with a special monthly allowance of ₹ 11,250 and other allowances applicable from time to time as per Rules.
